

Role of the Director Government Affairs, Europe

This is a leading advocacy role in our team. You should be passionate about advocacy and public affairs, about how to take a campaigning approach to build and execute advocacy strategy. The issues you will focus on cover Brussels but also European countries; you will combine the confidence and experience to engage externally with policy makers and other external stakeholders most weeks; you need to be passionate about the role and techniques of story-telling within advocacy.

You will collaborate with the local teams based across Europe to deliver a coordinated joint approach for external engagement on some of the key business issues. A number of the issues you will work on, are at the intersect of consumer healthcare and the environment.

A background in chemical and environmental issues will be an advantage.

Key responsibilities of the Director Government Affairs, Europe

Strategy development

- Define & execute government affairs strategies to support business objectives.
- Monitor relevant policies and regulations, identify risks and opportunities for EU and national level advocacy on priority topics; deliver analysis and policy insight to the business.
- Develop a stakeholder engagement approach that effectively deploys senior leaders, and provide strategic guidance and insight to support senior leader engagement
- Ensure clear correlation between the government affairs strategy and local business priorities. Bringing the outside in and inform the business about reputational threats and opportunities.
- Work closely with colleagues in other functions to promote the important role self-care plays for individuals and national healthcare.
- Support delivering European trade associations strategy and ensure internal alignment on policy positions and priorities and "speaking with one voice" when engaging in national trade associations.
- Contribute insight and intelligence to senior leader briefings, helping to ensure ongoing understanding of the political environment and the potential impact on the business





Reputation management

- Increasing awareness of the company purpose and building strong relationships with relevant governmental stakeholders.
- Deliver strategies for priority projects (issues and opportunities) to ensure that GSK Consumer Healthcare has a strong share of voice among external stakeholders (governmental and others).
- Deliver on our stakeholder engagement plans to ensure that the new company builds a strong external network built on trust and credibility with stakeholders of influence, including both governmental functions and non-governmental stakeholders.
- Represent Haleon externally in relevant trade associations.
- Support with planning of events, such as round table debates, on-line panels and the like.

Requirements

- Strategic thinking and ability to execute effectively (experience and proven track record in developing and executing policy campaigns and strategies)

- Proven ability to develop trust-based relationships with senior external stakeholders such as professional bodies, national governments and advocacy groups
- Highly skilled in managing complex issues (external and internal), identifying areas of control, mobilising the internal response and resolving effectively, especially in a highly regulated environment.
